Your booking will be confirmed on receipt of completed booking form. Notification of any cancellation must be in writing. Cancellations received before or on 19 April 2024 will be required to pay 20% of the full price of the package cancelled. Cancellations received on or after 3 May 2024 will be required to pay 60% of the full price of the package cancelled. Cancellations received on or after 24 May 2024 will be required to pay 100% of the full price of the package cancelled and no refunds will be made.

All payments paid by you will be reduced by any amounts due to us in accordance with this cancellation policy before they are returned to you.
